


## WHAT IS IPI?

IPI is a nonprofit organization originated in 2000 and headquartered in Barcelona, Spain. IPI's main goal is child protection including the promotion and defense of civil, social and individual rights; social assistance to minors and families; and the intervention in international adoption, among others.

IPI is a Licensed International Adoption Agency by the Catalan Government and by the local authority on adoption, the Catalan Institute of Adoption and Foster care, in order to carry out our activity in the countries where we work (Ethiopia, Mali, Ivory Coast, Senegal, Kazakhstan and Vietnam) with transparence and accountability.

The purpose of the NGO is to develop projects focused on the most disadvantaged children and young people in Africa and Asia, especially in fields such as education and health.






### WHAT IS FISIOS MUNDI?

tric field in Barcelona, but my most rewarding experience has been in international cooperation.


Countries I have worked in: Spain, Italy, Nicaragua, Nepal, and Vietnam.
